Cemetery Symbolism

Family research is one hobby that has the power to provoke the need to know more about our ancestors and their lives. But why has it become almost an obsession? Perhaps because this is our chance to truly become detectives. We are searching for the secrets and passions of our ancestors, and perhaps we are even learning more about ourselves in the process.

The research involved in genealogy eventually leads to cemetery visits and tombstone reading. What was once considered a morbid pastime has become a normal part of the investigative process for the family history researcher.

Cemeteries can tell us much about our ancestors. Information can be gleaned from the words carved on headstones. We can learn a great deal concerning family relationships from the placement of a grave within the cemetery itself.

As more and more researchers venture into cemeteries to seek out ancestral graves, questions arise about the meanings of the artwork and symbols found on the tombstones. The researcher wants to know what a symbol might mean and if the meaning might provide more clues about this ancestor and his/her life, ideals, associations, etc. Can reading and understanding these symbols help us gauge and unravel some quintessential element of this ancestor's life?

Understanding the Symbols

The task of interpreting the symbols on a tombstone is a daunting one. Though most symbols engraved on a stone have a textbook meaning, it is possible that the particular item you find engraved is there simply because someone liked the look of it. Therefore, it will have no meaning beyond the taste of the deceased or the preferences of those who choose the stone's appearance. The point is, many people who choose grave motifs have no idea that the ornamentation they select has meaning. What they do know is that they like the design and feel it is just somehow right. Also, the ideas of the person designing the monument cannot be known to us, so the true representation may never be ascertained.

Symbols can express ethnic identity, religious affiliation, association membership or simply the predilection of the time or community. A symbol that was commonly used in one area might mean something completely different in another area. Therefore, it is important to understand the history of the area and of the time.

During your visit to the cemetery, you may or may not be able to interpret the meaning of symbols on gravestones. Either way, you will enjoy the inherent beauty and workmanship involved in carving these intricate designs. Cemetery engravings are art in the truest sense of the word. The stonecutter was an artist and some of the sculptures you'll find in cemeteries are as beautiful as art found in the finest museums.

The article continues with Ms. Reid categorizing symbols under: *mortality, religion, plants, trees, hands, animals, resurrection/eternal life/immortality and trade & occupation.*



of original partners in the project left early on to start their own horror channels. *Horror Network* and *Fangoria TV* are also scheduled to debut soon after **The Horror Channel**. Three horror channels! The only thing that could top this would be two Halloweens a year!

CEO Nick Psalto and COO John Giunti hesitate divulging too much information on the programming; however, they have indicated that original short films, coverage of award shows and conventions and original programming are currently scheduled for air.

So, call your local cable provider and ask them to drop the **ESPN Shuffle Board Network** and replace it with all that's good in the world....**The Horror Channel**.

Today's Topic:
The Warrens

Every once in awhile individuals stand out from the rest and excel in a specific field. Their work creates a standard that most try to emulate and others try to debunk.

Ed and Lorraine Warren are those individuals. Their work in paranormal investigations has made them the foremost experts in psychic research. They have worked in some of the most interesting investigations in history, with the most famous being Amityville.

Since a young boy, Ed has been intrigued with the paranormal. Growing up in the rough side of Bridgeport, Connecticut, his family lived in a haunted house where he often would be confronted by a spirit. Lorraine's special gifts have been docu-

mented at UCLA. She is a clairvoyant, who uses her sixth sense to hear, feel and sense. She is also able to "see" an individual's Aura. Together they make an effective investigative team. Lorraine uses her abilities to decipher what type of spirit they are confronting and where most of the activity is occurring. Ed then uses this information to determine what course of action should be taken. They document all paranormal activity in every case. If the spirit turns out to be demonic and the church needs to be brought in, they have the evidence to back up any and all claims. Ed Warren works closely with the exorcist and lends a hand wherever one is needed. He has been attacked by evil spirits more times than he likes to remember. And if you think that the Warrens are in this for the money, you're wrong! The Warrens don't get paid for their services; housing and transportation is all they request from families.

The Warrens still conduct investigations, albeit very few due to their age, and hold

limited lectures that cover some of their investigations. Pictures, video and recordings are some of the never before published material that are presented to the audience. The Warrens also hold the largest collection of paranormal artifacts in their "Occult Museum". The contents of which will be donated to a British University in the future. Among the many artifacts are: possessed dolls, a pearl necklace that will choke its wearer and a mirror that was used to conjure demonic spirits. Why don't the Warrens destroy these items? The destruction of these artifacts could bring harm to the past owners as a kind of revenge for this act. It is also possible that the exorcised spirit may be released back to where it was originally cast out.




